MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (MoU) has been executed on 18.05.2022 at New Delhi

BETWEEN

Department of Agriculture & Farmers Welfare (DA&FW), Ministry of Agriculture & Farmers Welfare (MoA&FW), Government of India (GoI), New Delhi – 110001, through **Shri Samuel Praveen Kumar, Joint Secretary, DA&FW, MoA&FW, GoI**, Department of Agriculture & Farmers Welfare (DA&FW) (hereinafter called the “First Party”, which shall unless repugnant to the context shall mean and include their successors, assignees and administrators) ON THE FIRST PART

AND

M/s. Nagpur Nagrik Sahakari Bank Limited, 79, Dr. Ambedkar Square, Central Avenue, Nagpur – 440008 through **Shri Subhash Wamanrao Godbole Chief Executive officer**, (hereinafter called the “Second Party/Lender/Institution”, which shall unless repugnant to the context shall mean and include their successors, assignees and administrators) ON THE SECOND PART

WHEREAS, the **M/s. Nagpur Nagrik Sahakari Bank Limited, 79, Dr Ambedkar Square, Central Avenue, Nagpur – 440008** has already agreed to lend under the Central Sector Scheme” of financing facility under ‘Agriculture Infrastructure Fund’.

The DA&FW, Government of India has issued the operational guidelines for the Scheme (hereinafter called the “Scheme Guidelines”) by setting out broad features of the Scheme, terms for loan and subsidy reimbursement, selection of beneficiaries, roles and responsibilities of various agencies under the Scheme and its monitoring, etc. The Scheme Guidelines as amended from time to time shall be treated as part and parcel of this MoU and shall be read together for all purpose.

WHEREAS, MoU with DA&FW (GoI) is being executed for the implementation of Financing Facility Under Agriculture Infrastructure Fund Scheme to provide funding to Primary Agricultural Credit Societies (PACS), Marketing Cooperative Societies, Farmer Producers Organizations (FPOs), Self Help Group (SHG), Farmers, Joint Liability Groups (JLG), Multipurpose Cooperative Societies, Agri entrepreneurs, Startups, Central/State agency or Local Body sponsored Public Private Partnership Projects, Agricultural Produce Market Committees (APMCs) (APMCs operated regulated markets for agri allied sector produce including fisheries), State Agencies, National and State level federations of Cooperatives, Federations of FPOs and Federations of Self Help Groups (SHGs), etc.

WHEREAS, the Department of Agriculture & Farmers Welfare, Ministry of Agriculture & Farmers Welfare, Government of India is implementing an interest subvention and financial support scheme to cater to the medium /long term debt financing facility for investment in viable
