Subject:- Operational Guidelines of Central Sector Scheme of " Financing Facility under Agriculture Infrastructure Fund"

Sir,

I am directed to refer to this Department's letter of even number dated 17.07.2020 on the subject cited above vide which Operational Guidelines for the Central Sector Scheme of " Financing Facility under Agriculture Infrastructure Fund" were circulated and to say that following clarifications are issued with respect to the operational guidelines of the scheme:-

(i) With regard to Constitution of District Level Monitoring Committee (DLMC), it is clarified that if DDM, NABARD is not in a position to attend the meeting of DLMC, link officer for DDM i.e. LDM can work as Member Secretary for District Level Monitoring Committee.

(ii) With regard to eligible lending institutions, it is clarified that in addition to scheduled cooperative banks, DCCBs with whom PACS are affiliated shall also be eligible to participate under this scheme.
